- -Vote Specific Dates for In-Person Early Voting, April 2025 Annual Town Election Town Clerk Liza Landy said the Board previously voted on In-Person Early Voting and proposes the Board vote the hours to be Wednesday 4/2/25 to Wednesday 4/9/25 8:30-4 and Saturday 4/5/25, 9-3 (no hours Sunday).

MOTION to approve early voting hours as proposed, by Ms. Landy, by Mr. O'Loughlin, 2nd by Ms. Childs. Unanimous approval

-Building Department Recommended Fee Increase - Building Commissioner Tom Ruble said Rockland has not increased permit fees since 2013 and provided the Board an analysis of surrounding Towns fees with his recommendations. The Board approved the increase in new construction fees and will consider the residential fees at a future meeting.

MOTION to approve the increase of new construction fees as recommended, by Mr. O'Loughlin, 2nd by Mr. Ellard. Unanimous approval

-Other New Business Not Reasonably Anticipated -Mr. Lapp received an email from Abington BOS Chairman Kevin Donovan who gave notice Abington will be "Perambulating the Bounds" which locates the proper markers of the Town boundaries. He welcomes the Rockland Board to join them on 4/5/25. Mr. Lapp recommends the Board delegate the work and appoint Zoning Enforcement Officer Tom Ruble and Zoning Board Chairman Rob Rosa as representatives.

MOTION to appoint Mr. Ruble and Mr. Rosa to represent Rockland in the task as presented, by Mr. O'Loughlin, 2nd by Ms. Childs. Unanimous approval

-Snow & Ice Stipend - Highway Superintendent Dave Taylor requested the Board consider a Snow & Ice stipend as done in previous years. Mr. Ellard said he would prefer the stipend show as a line item on the May Town Warrant and Mr. Lapp said the stipend is included in the Snow & Ice line item. The Board briefly discussed.

MOTION to approve Snow & Ice Stipend for Mr. Taylor with the same terms & conditions as previous years, with a cap of \$10,000 (\$50 an hour), by Mr. O'Loughlin, 2nd by Ms. Childs. 3-1(Ellard)
