Mr. White, working with Assessor Meg Peterson & Town Collector Judy Hartigan, and is requesting the Select Boards approval to add a box on the excise bills to allow residents to donate to veterans.

- Mr. Lapp gave an overview of the previous Select Board disciplinary hearing and Town Land Counsel Bob Galvin provided the Board with the status of the previously given order. Attorney Galvin would support the Board's decision to extend the suspension for a couple more weeks to allow the requirements to be resolved but he said there will be bigger issues if the timeline is not met. Mr. Walter Sullivan, attorney for owner William Barry, stated the matter of the LLC ownership and insurance is in the process of being fixed and will be in place once all Town licenses/permits are complete. He gave a status report on the work Mr. Barry has in process and his assurance of the completion. The Board commented on the numerous compliance issues. Building Inspector Tom Ruble, Electrical Inspector John Kemmett, Deputy Fire Chief Tom Heaney, & Health Agent Delshaune Flipp reported on the prior day's inspections and voiced their concerns on the hazardous outstanding conditions. The Board discussed and made it clear they want to see some serious progress at the 4/1 meeting. Without proof of timely improvements, the Board will consider revoking the Innholder's License to sell alcoholic beverages.

- -FY26 Budget –Mr. Lapp presented the draft of the FY 26 Budget. School Superintendent Dr. Alan Cron & Asst. Superintendent Jane Hackett requested additional funds of \$300,000 and provided a PowerPoint presentation with an explanation for the request. The Board commented understanding the request but stressed the financial strain of the budget. Mr. Lapp, working with Highway Superintendent Taylor, presented an option to fund the School's request by cutting funding from three Highway articles (\$250,000) and eliminating one School article (\$50,000). Mr. O'Loughlin said he would be amendable with the solution and thanked Mr. Taylor; he said the Town & School work well together. The Board had a consensus to support Mr. Lapp's recommendation. Dr. Cron and Ms. Hackett thanked the Board and Mr. Lapp.
- -Town Administrator Performance Evaluation prepared by Town Counsel John Clifford Ms. Needham gave an overview of the TA performance evaluation and provided the ratings & a sample of comments for each category. The Board expressed opinions on the evaluation report and thanked Attorney Clifford.
