Town Counsel John Clifford provided summaries from meetings with the relevant departments on 3/31/25, along with follow up emails regarding the status since the last hearing on 3/18/25 and a summary of information by Attorney Walter Sullivan, counsel for the Banner. As of now, there has been little or no substantive progress toward bringing the building into compliance with the applicable safety & building codes. Atty. Sullivan proposed his client voluntarily agree to a ninety(90) day suspension of the liquor license to get the necessary permits and have the corrective work done. In the interest of maintaining the commercial viability of the property, Mr. Clifford recommends the Board consider accepting the voluntary 90-day suspension, making it clear the suspension would not toll and/or inhibit any other ongoing enforcement issues and/or fines. Deputy Fire Chief Heaney reported as of today there is still no fire alarm system plan in place and Mr. O'Loughlin said this should be the priority. The Board commented, stating their concerns with the Banner's ability to meet deadlines, and requested progress reports during the 90 day period. Mr. O'Loughlin would prefer Mr. Barry not be the onsite general contractor doing the work himself, rather he obtains a separate general contractor. The Board agreed with Mr. Clifford's recommendation of a 90 day suspension with 30 day updates.
