MOTION to reopen the Public Hearing, by Ms. Needham, 2<sup>nd</sup> by Mr. O'Loughlin. Unanimous approval.

Town Counsel John Clifford said the continuation of the Public Hearing is 90 days after the April hearing. The Select Board requires the Banner to demonstrate that they have fulfilled all Town requirements to bring the property into compliance before the Board approval is granted to have the alcohol license reinstated. Banner Attorney Walter Sullivan informed the Board of the work that has been completed and said Mr. Barry is asking to open the first floor restaurant only, keeping the second & third floors blocked off. Mr. Clifford said the Board may grant the return of the liquor license with the opening of the first floor restaurant subject to approval from the Board of Health. He said this would limit operations to the first floor restaurant with restricted access to the second & third floors until all applicable codes have been met. Building Inspector Tom Ruble said the first floor does not include the café area. The Select Board, Electrical, Building & Fire Departments commented.
