-Zoning Board of Appeals Reappointment –Rob Rosa resigned from the ZBA and submitted his resignation letter to Clerk's office on 7/1/25. Mr. Rosa said he acted in haste and is asking the Select Board to reinstate his membership. Ms. Childs and Mr. O'Donnell commented in support of the reappointment. Mr. Ellard said he was flip flopping and thought the tone of Mr. Rosa's resignation letter was jolting. He hopes Mr. Rosa can resolve his issues but will support the reappointment. Mr. O'Loughlin said Mr. Rosa will have some resolutions to make with the ZBA members and Town departments.

MOTION to approve the ZBA reappointment of Rob Rosa for the completion of the term ending 5/31/26, by Mr. O'Donnell, 2nd by Ms. Childs. Unanimous approval

Mr. Ellard said the ZBA currently has three alternate positions open and encourages residents to get involved.

-Update & Re-Vote Board Signature Authority Designation for Expenditures -

Mr. Lapp recommended the Board designate the positions of Chair and Vice Chair as the authorized signatories, replacing the past practice of authorizing individual names. Mr. Ellard made a request that if a member chooses not to sign the weekly warrant, it will not be released until further Board review. Mr. O'Loughlin agreed to make the commitment if a member has a question or concern, a discussion will be held before the release of the warrant.

MOTION to designate the Select Board Chair as primary authorized signature and the Select Board Vice Chair secondary authorized signature, Mr. O'Donnell, 2nd by Mr. Ellard. Unanimous approval.

- -Pleasant Street Landfill RFP Update- Mr. Lapp provided an update on the 279 Pleasant Street Landfill and said the Request for Proposal (RFP) is posted for the "Permitting, Design and Construction of the Landfill Cap & Post-Closure Use Project. The Board briefly commented.
- -Select Board Liaison Appointments- Mr. O'Loughlin reached out separately to the members and a decision was made to eliminate the position of liaison. Two exceptions: Mr. Ellard will continue as the rep on the Plymouth County Advisory Board & Mr. O'Donnell will continue with the Open Space & Recreation Committee and the Open Space Committee. Mr. O'Loughlin said he hopes this will open the line of communication for SB members and other Town Boards & Committees.

- 5. Select Board Liaison Update Mr. O'Donnell said the OSRC & MAPC Housing had a kick-off meeting on Monday. He said it was a great discussion and thanked the committee members.

- -Questions have been received regarding the authority of the Police Chief vs. the Select Board. Rockland has a "strong" Police Chief, per the Charter "the chief of police shall have full authority to appoint, demote, suspend and terminate all the police officers and command officers of the police department".

- -Rockland Board of Water Commissioners has one vacancy to fill the position until the next election
