- -Zoning Bylaw Review Committee Town Planner Allyson Quinn recommends the need to formalize a five member Zoning Bylaw Review Committee and how it should include exploring changes to the existing Downtown Rockland Revitalization Overlay District or "DRROD" 40R. She detailed how the economy is evolving and that Rockland needs to be responsive to emerging at-home markets and inclusive of new uses in the local small business community. Ms. Quinn suggests the committee should include residents and business owners. She will update the Board at a future meeting.
- -Parks Commissioners Update Chair Brian Martin provided a brief update on the current projects going on in the Park Department including the Spring Street baseball field fencing and the Bicentennial Track replacement. Mr. Martin said the Commissioners are in early talks with the Futures Collegiate Baseball League and the potential of bringing the league to Rockland. Future League Commissioner Joe Bolucci provided details of the summer league and thanked everyone for the opportunity to speak. The Board commented and asked questions. Mr. O'Loughlin said they look forward to hearing from the Park Commissioners with more details about this exciting possibility utilizing the Veterans Memorial Stadium.
- -Community Development Block Grant (CDBG) Requested Wavier of the Housing Rehabilitation Program Project Cap

The Cannabis Control Commission is asking for public comments by September 8th. Mr. Lapp recommends he draft a letter with the town's recommendation on behalf of the Board. Police Chief Zeoli commented, and the Board held a brief discussion.
