MOTION to approve the minutes of 9/16/2025, by Mr. O'Donnell, 2nd by Ms. Needham. Unanimous approval

- 4. New Business
- -Union Point Update- John Twohig, New England Development/Brookfield Properties Paul Cicada and John Twohig presented a Power Point on the Redevelopment Overview of Union Point (South Weymouth Naval Air Station) including a brief history, conceptual master plan, water & sewer infrastructure, moving forward, funding, and redevelopment interests. Board members asked questions with a brief discussion. The Board thanked Mr. Twohig and Mr. Cicada for attending the meeting and are looking forward to future updates.
- -Department Head Updates-
- -Treasurer -\$1.5M Bonding Borrowing: Review and Approve Note Results & Related Matters Mr. Lapp provided a brief review of \$1.5M bonding borrowing.

Treasurer Allison Sullivan said results were provided to the Board of the BAN sale that happened on 9/30/25 and she is requesting the Board's vote of approval of the sale. She gave a brief update on the Treasurer Department and was pleased to announce the hiring of a new Assistant Treasurer and having a fully staffed office.

Mr. O'Loughlin read: I, the Clerk of the Select Board of the Town of Rockland, Massachusetts, certify that at a meeting of the Board held on October 7, 2025, of which all members of the board were duly notified and at which a quorum was present, the following votes were unanimously passed, all of which appear upon the official record of the board in my custody:

- -Vote to approve the sale of \$1,500.000 4.00 percent General Obligation Bond Anticipation Notes (the "Notes") of the town dated October 23, 2025, and payable October 23, 2026, to Fidelity Capital Markets, a division of National Financial Services LLC, at par and accrued interest, if any, plus a premium of \$18,195.
- -Further Vote that in connection with the marketing and sale of the Notes, the preparation and distribution of a Notice of Sale and Preliminary Official Statement dated September 23, 2025, and a final Official Statement dated September 30, 2025, each in such form as may be approved by the Town Treasurer, be and hereby are ratified, confirmed, approved and adopted.
- -Further voted that the Town Treasurer and the Select Board be, and hereby are, authorized to execute and deliver a significant events disclosure undertaking incompliance with SEC Rule 15c2-12 in such form as may be approved by bond counsel to the Town, which undertaking shall be incorporated by reference in the Notes for the benefit of the holders of the Notes from time to time.
- -Further vote that we authorize and direct the Town Treasurer to establish post issuance federal tax compliance procedures and continuing disclosure procedures in such forms as the Town Treasurer and bond counsel deem sufficient, or if such procedures are currently in place, to review, and update said procedures, in order to monitor and maintain the tax-exempt status of the Notes and to comply with relevant securities laws.

- -Further vote that any certificates or documents relating to the Notes (collectively, the "Documents"), may be executed in several counterparts, each of which shall be regarded as an original and all of which shall constitute one and the same document; delivery of an executed counterpart of a signature page to a Document by electronic mail in a ".pdf" file or by other electronic transmission shall be as effective as delivery of manually executed counterpart signature page to such Document; and electronic signatures on any of the Documents shall be deemed original signatures for the purposes of the Documents and all matters relating thereto, having the same legal effect as original signatures.
- -Further vote that each member of the Select Board, the Town Clerk and the Town Treasurer be and hereby are, authorized to take any and all such actions, and execute and deliver such certificates, receipts or other documents as may be determined by them, or any of them, to be necessary or convenient to carry into effect the provisions of the forgoing votes.
- -I further certify that the votes were taken at a meeting open to the public, that no vote was taken by secret ballot, that a notice stating the place, date, time and agenda for the meeting (which agenda included the adoption of the above votes) was filed with the Town Clerk and a copy thereof posted in a manner conspicuously visible to the public at all hours in or on the municipal building that the office of the Town Clerk is located or, if applicable, in accordance with an alternative method of notice prescribed or approve by the Attorney General as set forth on 940 CMR 29.03(2)9b), at least 48 hours, not including Saturdays, Sundays and legal holidays, prior to the time of the meeting and remained so posted at the time of the meeting, that no deliberations or decision in connection with the sale of the Notes were taken in executive session, all in accordance with G.L. c.30A, §§18-25, as amended.
